# Your feedback on the designs

So far, the key themes from the feedback includes:



#### Size and scale

Most residents and neighbours were positive about ideas for the scale and location of the new homes, though some thought they should be lower or further away from neighbours.



## Overlooking

There was some concern about overlooking from the entrance to the new homes into surrounding homes and gardens.



#### Security

Residents felt strongly that adequate security measures will be required for the new improvements to be safe. Gates were requested for the estate.



#### Play and landscaping

Many residents supported the idea of moving the existing playground and wanted to see improved equipment.

Feedback showed a preference to move play areas to the back of the estate.



#### Bin stores and bulky rubbish

The bin stores are seen as an area of focus for anti-social behaviour that should be addressed, alongside preventing people from the wider area contributing to fly tipping.



# Our proposals



The proposed four-storey building could provide 18 homes: 4 one-bed, 10 two-bed, and 4 three-bed. This is one more home than in the February 2025 proposals, without significant changes to the building's size or shape.

Eleven homes are proposed for intermediate rent which is a reduced level of rent for key workers living or working in Camden, and seven for social rent. All homes would be let at below market rate.

**Social rent homes** would follow a Local Lettings Plan, giving priority to eligible Raglan Street Estate **residents** before others on Camden's housing waiting list.

The proposals would re-provide play areas and storage sheds within the estate, while introducing improvements across the estate, like new gardens and landscaping and a secure bin store. They also aim to provide two on-street blue badge parking spaces and new cycle storage.
